

Vermont Nurses In Partnership (VNIP) Site License Agreement

NOTICE TO USERS: You must read this license carefully before using the Licensed Materials. By using the Licensed Materials you are agreeing to be bound by the terms of this license. **IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT INSTALL, USE, COPY, TRANSMIT OR DISTRIBUTE THESE LICENSED MATERIALS.**

EVALUATION LICENSE. VNIP may grant Licensee the right to use the Licensed Materials on one computer for up to ten days, after which it must either delete all VNIP files from its computer, or purchase a Site License. Any such Evaluation License is subject to all of the terms and conditions set forth in this Site License Agreement.

I. Content of Licensed Materials; Grant of License

A. The materials that are the subject of this Agreement shall consist of electronic information published or otherwise made available by VNIP (hereinafter referred to as the "Licensed Materials").

The VNIP Licensed Materials are provided "AS IS," without a warranty of any kind. Licensee and its Authorized Users acknowledge that the copyright and title to the Licensed Materials and any trademarks or service marks relating thereto remain with Licensor. Neither Licensee nor its Authorized Users shall have right, title or interest in the Licensed Materials except as expressly set forth in this Agreement.

Licensor hereby grants to Licensee non-exclusive, non-transferable right to access and use the Licensed Materials for Licensee's internal purposes and the right to provide the Licensed Materials to Authorized Users in accordance with this Agreement. Authorized users are limited to the employees of the licensed agency.

This license does not grant the Licensee any right to any enhancement or update.

The Licensed Materials are owned and copyrighted by VNIP. This license confers no title or ownership in the Licensed Materials and should not be construed as a sale of any right in the Licensed Materials. The Licensed Materials are protected by United States copyright law and international treaty provisions. Licensee acknowledges that no title to the intellectual property in the Licensed Materials is transferred to it. Licensee further acknowledges that title and full ownership rights to the Licensed Materials will remain the exclusive property of **VT Nurses In Partnership, Inc** and that Licensee will not acquire any rights to the Licensed Materials except as expressly set forth in this license. Licensee also agrees that any copies of the Licensed Materials will contain the same proprietary notices that appear on and in the Licensed Materials.

Licensee agrees that the Licensed Materials will not be shipped, transferred or exported into any country or used in any manner prohibited by the United States Export Administration Act or any other export laws, restrictions or regulations.

C. Types of License

(a) **Single-Site License:** This license is for an organization with one primary physical location and a single organizational unit, such as a hospital, home health agency, or public health office. A Single-Site License provides access to the licensed materials from a Licensed Site in one such geographic location or organizational unit. An organization with a single organizational unit that has multiple campuses that are geographically contiguous is considered a single site.

(b) **Multi-site License:** This license is required for an organization with multiple locations within one city or geographic area, or for an organization with locations in more than one city, state, or country, even if administration of the license is done centrally on behalf of all locations.

D. Detection of Prohibited Uses

Licensee is responsible for taking reasonable measures to prevent prohibited uses, and to promptly notify VNIP of any infringements of copyright or prohibited use of which Licensee becomes aware.

III. Fees

Licensee shall make payment to Licensor for use of the Licensed Materials pursuant to the terms set forth in the resource request form or as per negotiated contract. **{Note: Pricing follows a model that is based on an initial site licensing fee and periodic renewal fees that ensure updated materials and ongoing cyber-communications.}**

VNIP will take into account any affiliated institutions (e.g., hospitals, research institutes, etc.) that will have access to the Licensed Materials in determining whether a single-site or multi-site license is required. If a multi-site license is required, the total licensing price will generally be determined by adding the charges calculated for each individual site.

IV. Authorized Use of Licensed Materials

Authorized Uses. Licensee and Authorized Users may make all use of the Licensed Materials as is consistent with the Fair Use Provisions of United States and international law. Nothing in this Agreement is intended to limit in any way whatsoever Licensee's or any Authorized User's rights under the Fair Use provisions of United States or international law to use the Licensed Materials.

The Licensed Materials may be used for purposes of research, education, performance development and/or evaluation or other non-commercial use as follows:

Customization - Materials, documents, and teaching materials may be customized for use within the Licensee organization, incorporating the organization's policy, job descriptions, values, etc.

Display. - Licensee and Authorized Users shall have the right to electronically display the Licensed Materials within its licensed site.

Print and/or Copy. - Licensee and Authorized Users may print a reasonable portion of the Licensed Materials and photocopy for instructional use with employees of Licensee.

Course Packs. - Licensee and Authorized Users may use the Licensed Materials in connection with specific courses of instruction offered by Licensee

Caching. - Licensee and Authorized Users may make such local digital copies of the Licensed Materials as are necessary to ensure efficient use by Authorized Users by appropriate browser or other software.

V. Specific Restrictions on Use of Licensed Materials

Licensee may not: redistribute the licensed materials; use the licensed materials in a manner that is disparaging to the VT Nurse Internship Project or VT Nurses In Partnership, Inc.; modify, translate, or create derivative works based on the licensed materials (unless derivative works are added to the VNIP resources); or rent, lease, transfer or otherwise transfer rights to the licensed materials.

Unauthorized Use. Except as specifically provided elsewhere in this agreement, Licensee shall not knowingly permit anyone other than Authorized Users to use the Licensed Materials.

Modification of Licensed Materials. Licensee shall not create a derivative work of the Licensed Materials without the prior written permission of Licensor (other than customizations for use within the Licensee organization). All derivative works will be added to the VNIP resource compilation.

Other Instruction – Licensee shall not provide Licensed Materials, any derivative of these materials or training specific to either of these to agencies, educators, managers or staff other than those employed by the Licensee.

Commercial Purposes. Other than as specifically permitted in this Agreement, Licensee may not use the Licensed Materials for commercial purposes, including but not limited to the sale of the Licensed Materials, bulk reproduction or distribution of the Licensed Materials in any form or provision of educational programming for other than employees of the Licensee.

Removal of Copyright Notice. Licensee may not remove, obscure or modify any copyright or other notices included in the Licensed Materials.

VI. Licensor Performance Obligations

Support. Licensor will offer reasonable levels of continuing support, as per contract agreement, to assist Licensee and Authorized Users in use of the Licensed Materials.

Notification of Modifications of Licensed Materials. Licensee understands that from time to time the Licensed Materials may be added to, modified, or deleted from by Licensor and/or that portions of the Licensed Materials may migrate to other formats. Notice of changes in materials will be distributed via cyber-communications.

VII. Licensee Performance Obligations

Protection from Unauthorized Use. Licensee shall use reasonable efforts to inform Authorized Users of the restrictions on use of the Licensed Materials. In the event of any unauthorized use of the Licensed Materials by an Authorized User, (a) Licensor may terminate such Authorized User's access to the Licensed Materials, (b) Licensor may terminate the access of the Internet Protocol ("IP") address(es) from which such unauthorized use occurred, and/or (c) Licensee may terminate such Authorized User's access to the Licensed Materials upon Licensor's request. Licensor shall take none of the steps described in this paragraph without first providing reasonable notice to Licensee (in no event less than ten days) and cooperating with the Licensee to avoid recurrence of any unauthorized use.

Maintaining Confidentiality of Access Passwords. Where access to the Licensed Materials is to be controlled by use of passwords, Licensee shall maintain the confidentiality of any institutional passwords provided by Licensor.

Except for termination for cause, Licensor hereby grants to Licensee a nonexclusive, royalty-free, perpetual license to use any Licensed Materials that were accessible during the term of this Agreement. Such use shall be in accordance with the provisions of this Agreement, which provisions shall survive any termination of this Agreement. The means by which Licensee shall have access to such Licensed Materials shall be in a manner and form substantially equivalent to the means by which access is provided under this Agreement.

VIII. General Provisions

Limitations: Notwithstanding anything else in this Agreement:

Neither party shall be liable for any indirect, special, incidental, punitive or consequential damages, including but not limited to loss of data, business interruption, or loss of profits, arising out of the use of or the inability to use the Licensed Materials.

Licensor makes no representation or warranty, and expressly disclaims any liability with respect to the content of any Licensed Materials, including but not limited to errors or omissions contained therein, libel, infringement of rights of publicity, privacy, trademark rights, moral rights, or the disclosure of confidential information.

The Licensed Materials are provided on an "as is" basis, and Licensor disclaims any and all other warranties, conditions, or representations (express, implied, oral or written), relating to the Licensed Materials or any part thereof, including, without limitation, any and all implied warranties of quality, performance, merchantability or fitness for a particular purpose. Licensor makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb or other such computer program. Licensor further expressly disclaims any warranty or representation to Authorized Users, or to any third party.

Assignment and Transfer: Licensee may not assign, directly or indirectly, all or part of its rights or obligations under this Agreement without the prior written consent of the Licensor.

Force Majeure: Neither party shall be liable in damages or have the right to terminate this Agreement for any delay or default in performing hereunder if such delay or default is caused by conditions beyond its control including, but not limited to Acts of God, Government restrictions (including the denial or cancellation of any export or other necessary license), wars, insurrections and/or any other cause beyond the reasonable control of the party whose performance is affected.

Entire Agreement: This Agreement constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.

Severability: If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

Waiver of Contractual Right: Waiver of any provision herein shall not be deemed a waiver of any other provision herein, nor shall waiver of any breach of this Agreement be construed as a continuing waiver of other breaches of the same or other provisions of this Agreement.

Notices: All notices given pursuant to this Agreement shall be in writing and may be hand delivered, or shall be deemed received within 5 days after mailing if sent by registered or certified mail, return receipt requested. If any notice is sent by facsimile, confirmation copies must be sent by mail or hand delivery to the specified address. Either party may from time to time change its Notice Address by written notice to the other party.
